

# Beacon Paws LLC

## Owners Agreement

The undersigned (hereafter "Owner") has requested the services of Beacon Paws LLC and in consideration agrees to the following: Beacon Paws LLC agrees to allow Owners dog into Beacon Paws LLC provided all terms and conditions are met.

1. The owner understands that his/her dog(s) must be at least 4 months old.
2. The owner understands that his/her dog(s) must be free of fleas and ticks. Any dog found with fleas will have to be treated with a flea and tick bath at the owner's expense.
3. The owner understands that his/her dog(s) MUST be up to date on required vaccines including rabies and distemper. Bordetella (kennel cough) is a HIGHLY recommended vaccination, It is known to protect against only a few known strains of the virus. However, some protection is better than no protection.
4. The owner understands that Beacon Paws LLC is an open play environment and because of this there are inherent risks. Owner recognizes and accepts potential risks involved in such activity. It is expressly agreed by Owner and Beacon Paws LLC that Beacon Paws LLC shall be held harmless and in no event be held responsible for any and all acts or behavior of Owner's dog while in care of Beacon Paws LLC, to include payment of costs for injury to staff or other animals or damage to Owner's dog(s) from disease, theft, fire, death, escape, injury or harm to person's other dog(s) or property by Owner's dog(s), provided reasonable care has been exercised by Beacon Paws LLC.
5. The Owner understands that if his/her dog (s) exhibits aggressive behavior, the owners will be notified and the dog will be kept separate from other dogs. We may conclude at any time that the dog is not appropriate for Beacon Paws LLC daycare or the social boarding program. Beacon Paws LLC can refuse any dog at any time at their own discretion.
6. The Owner understands and agrees that Beacon Paws LLC shall not be liable for any medical or other problems Owner's dog(s) develops. If the pet becomes ill or if the pet otherwise requires professional attention, Beacon Paws LLC, in its sole discretion, may engage the services of a veterinarian to treat the pet, and the expenses shall be paid by owner. The owner further releases Beacon Paws LLC of any liability whatsoever from his/her dog(s) attending Beacon Paws LLC, or from his/her dog(s) being cared for off the Beacon Paws LLC premises. Owner further agrees to indemnify Beacon Paws LLC for any claims asserted against such parties as a result of or arising from conduct of Owner's dog(s).
7. The Owner certified that His/her dog(s) are in good health, and had not been ill with any communicable conditions in the past 30 days, and is up to date on all vaccinations. The Owner further understands that Beacon Paws LLC has relied upon Owner's representation of their dog(s).
8. All charges incurred by owner shall be payable upon pick-up of dog(s). Beacon Paws LLC in hereby granted a lien on the dogs(s) for any and all unpaid charges. If the dog(s) is not picked up within three calendar days after the dog(s) was due to be picked up, the dog(s) shall be deemed to abandoned.
